

Except as may be modified by resolution of the Board of Directors, prohibited vehicles would include, without limitation, any vehicle: (1) with more than two axles, (2) oversized (higher than eight feet, wider than eight feet or longer than twenty feet), unless such vehicle is a boat, recreational vehicle or camper.

- (b) Recreational Vehicles: Campers, boats, household utility trailers and recreational vehicles may be parked on a Lot provided they are parked in a manner and location that does not endanger the safety of any person traveling on the roads within the Association. Campers and recreational vehicles may not be used for accommodations for more than 72 consecutive hours except in designated camping areas. Unlicensed trail bikes, dune buggies, all-terrain vehicles and snowmobiles may be transported into the Submitted Land on a licensed trailer and may be stored on a Lot and out of view of the neighboring properties, but shall not be operated on the Submitted Land.
- (c) Junk or Derelict Vehicles: All vehicles within the boundaries of Lake Holiday must be operable, display current state registration license plates and a current inspection sticker.
- (d) Use of Common Property Streets and Trails: All motor vehicles, including, but not limited to motorcycles, shall be driven only upon Common Property roads. Only motor vehicles authorized by the Board of Directors for Upkeep of the Common Property shall be driven on trails or unpaved portions of Common Property. Vehicles may not be parked on the roads except during weather conditions that make the use of steep driveways unsafe and during driveway construction or repair that prevent the use of such off-road parking. Vehicles shall not be parked in a manner that interferes with the maintenance of the Common Property roads. At no time, except for loading and unloading purposes, may construction vehicles be parked on the Common Property roads.
- (17) Timesharing. No Lot shall be subjected to or used for any timesharing, cooperative, licensing or other arrangement that would entail weekly, monthly or any other type of revolving or periodic occupancy by multiple Owners, cooperators, licensees or timesharing participants.
- (18) Animals. The maintenance, keeping, boarding or raising of animals, livestock, poultry or reptiles of any kind, regardless of number, is prohibited on any Lot or upon the Common Property, except that guide animals and a reasonable number of orderly, traditional domestic pets (e.g., three dogs, cats or caged birds) are permitted subject to the Rules and Regulations adopted by the Board of Directors; provided, however, that such pets are not kept or maintained for commercial purposes or for breeding. Any pet causing or creating a nuisance or unreasonable disturbance or noise, upon appropriate action by the Rules Enforcement Subcommittee, must be permanently removed from the Submitted Land. Pets shall not be permitted upon the Common Property unless accompanied by someone who can control the pet and unless carried or leashed. The person walking the pet shall clean up pet droppings. Any Owner who keeps or maintains any pet upon any portion of the Submitted Land shall be deemed to have indemnified and agreed to hold the Association and each Owner free and harmless from any loss, claim or liability of any kind or character whatever arising by reason of keeping or maintaining such pet within the Submitted Land. All pets that regularly leave the Lot must otherwise be registered and inoculated as required by law.
