Dear Sirs:

I am in receipt of your letter dated February 8, 2006 and LHEUC's letter dated March 10, 2006. These letters also appear on the website operated by the Association and the Utility at [www.lake-holiday.org](http://www.lake-holiday.org). Both letters contain a number of factual errors and misrepresentations. Several property owners have alleged that different versions of the February letter were mailed to membership lot owners and homeowners. If this is the case, please forward to me copies of all versions of these letters sent to property owners by Wednesday, March 15<sup>th</sup>.

These are important matters concerning the Association.

Pursuant to Va. 55-510.2, we hereby request that you put a date-ordered, equally prominent and visible link to our response to your letters on the Association's website and keep this link active for as long as links to these letters appear. Further, we request that the Association distribute at its expense our response to your letter via regular first class mail in an envelope bearing Lake Holiday's logo. Both of these methods were chosen by the Board to distribute its message to property owners. By implication, you determined these methods to be reasonable and effective.

It is important to recognize that mailings made using the official Lake Holiday envelope carry a certain weight with Lake Holiday's members. Likewise, the official website is a well-recognized method for member's to learn information about the community. No private mailing or posting on a third-party website can approach the weight given your comments made in an official capacity. We urge you to respect this important right of free speech

If the Association's employees are unable to handle the distribution of the mailing, we will do so provided either the Association or the Utility reimburse the cost of the mailing. Please let us know whether you would prefer to handle the distribution directly or would rather we do it with reimbursement.

We request that the document be mailed by Monday, March 20<sup>th</sup>, and that the website link be active by Friday, March 17<sup>th</sup>.

Further, in order for us to make a timely response to your letters, we request that you let us no later than Wednesday, March 15<sup>th</sup> of your intention to honor or disallow this request.

We will be damaged if we are denied equal protection and free speech in the fashion outlined above, so I urge you to grant this request.
